- 4) ALL TEMPORARY SIGNAGE SHALL CONFORM TO THE SUBMITTED SITE PLAN.
- 5) THE APPLICANT SHALL DISPLAY A COPY OF THIS TEMPORARY SIGN PERMIT DURING NORMAL BUSINESS HOURS.
- 6) ALL TEMPORARY IMPROVEMENTS MADE TO THIS SITE AND THE ABUTTING STREETS SHALL BE REMOVED UPON EXPIRATION OF THE PERMIT.
- 7) ALL APPLICABLE CITY CODE REQUIREMENTS SHALL BE SATISFIED.
- 8) THE APPLICANT SHALL BE RESPONSIBLE FOR LEAVING THE SITE FREE OF DEBRIS, LITTER, OR ANY OTHER EVIDENCE OF THE SIGNAGE UPON EXPIRATION OF THE PERMIT.
- 9) NO SIGNS SHALL BE LOCATED IN THE PUBLIC RIGHT-OF-WAY.

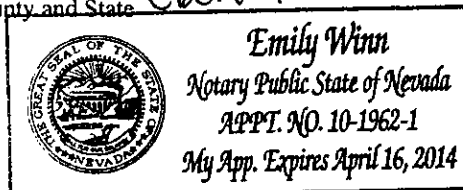

Justification Letter for Temporary Sign Permit
Craig Marketplace Art Festival

The event will be an outdoor arts and crafts fair, to be held Saturday and Sunday May 5 & 6, 2012 at Craig Marketplace shopping center, located at 7121-31 W. Craig Road at Tenaya Way in Las Vegas.

Local artist Mark Vranesh will coordinate the artisans and work with the Center management to create the weekend community event. The Department of Public Works has approved and issued the special event permit for the Craig Marketplace Art Festival.

Signage request for the event is as follows:

Banners will be installed on Monday April 30 and removed at the close of the show on Monday May 7, 2012. (one week)

2 Banners 3'x10' full color professionally produced.

"ART FESTIVAL THIS WEEKEKND"

These banners will be staked on grass near the ground at the vehicle entrances on Tenaya Way and Craig Road

2 Banners 4' x 25' full color professionally produced.

"ART FESTIVAL THIS WEEKEND"

One banner will be installed by Great American Capital on the side of Joey's Grill, one of their tenants in the shopping center.

One banner will be installed in the interior area of the shopping center, set back from the entrance on Craig Road.

5 directional stake signs 24"x24" "ART FESTIVAL THIS WEEKEND" will be installed on Saturday morning May 5 and removed at the close of the show May 6. The locations are designated on the site plan.

The placement of the signages will be a joint effort by show organizer Mark Vranesh and Great American Capital maintenance staff.

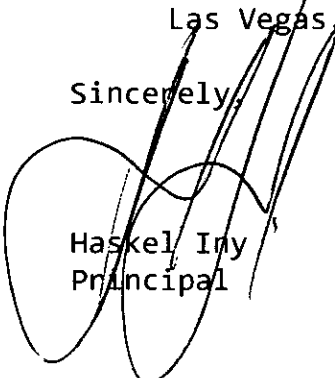
