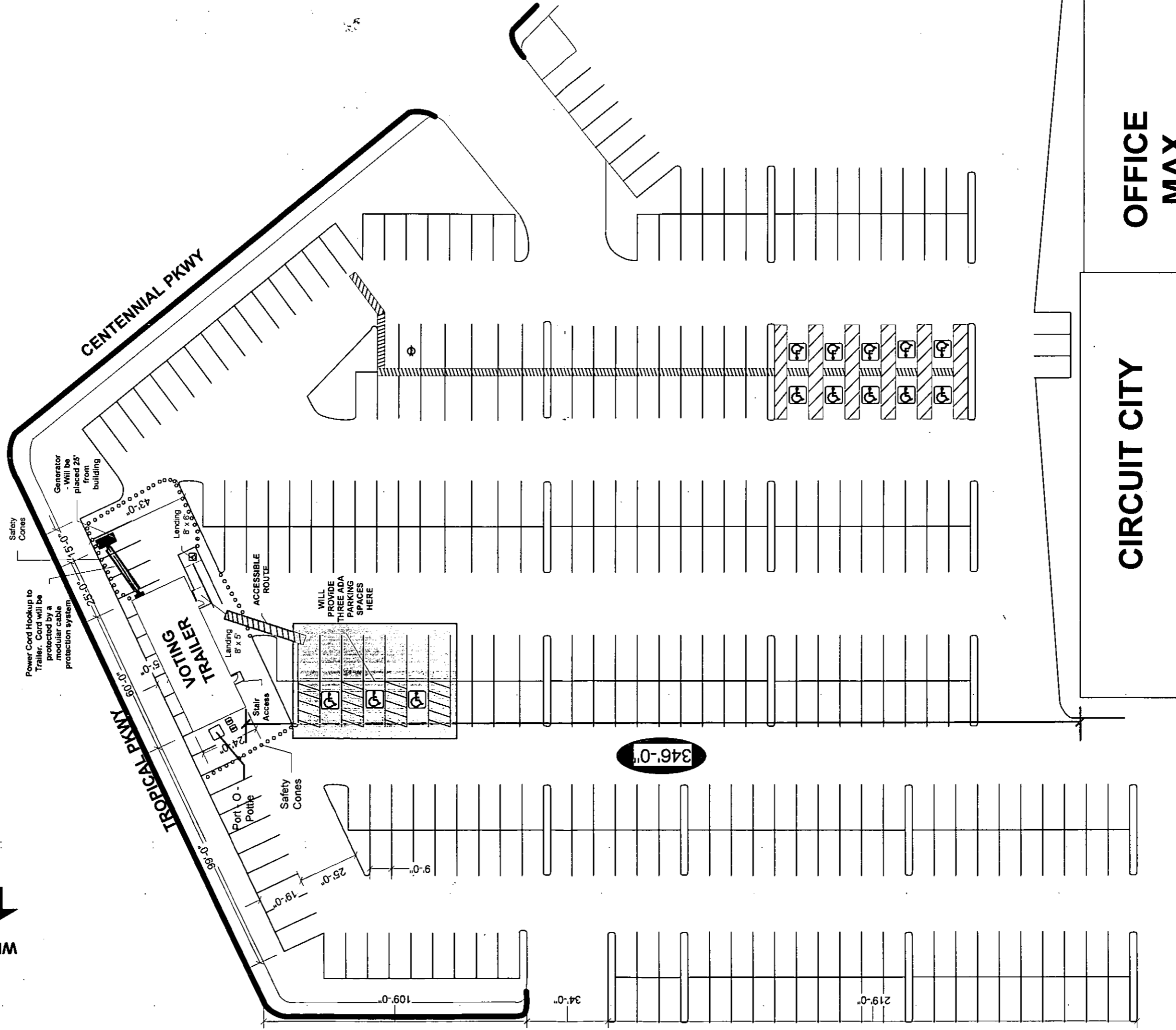
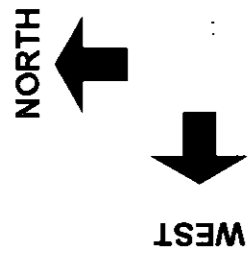


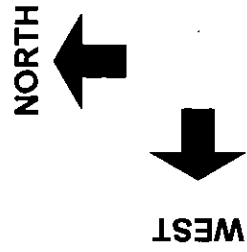
2012 Election Cycle - Early Voting Trailer Site Plan -

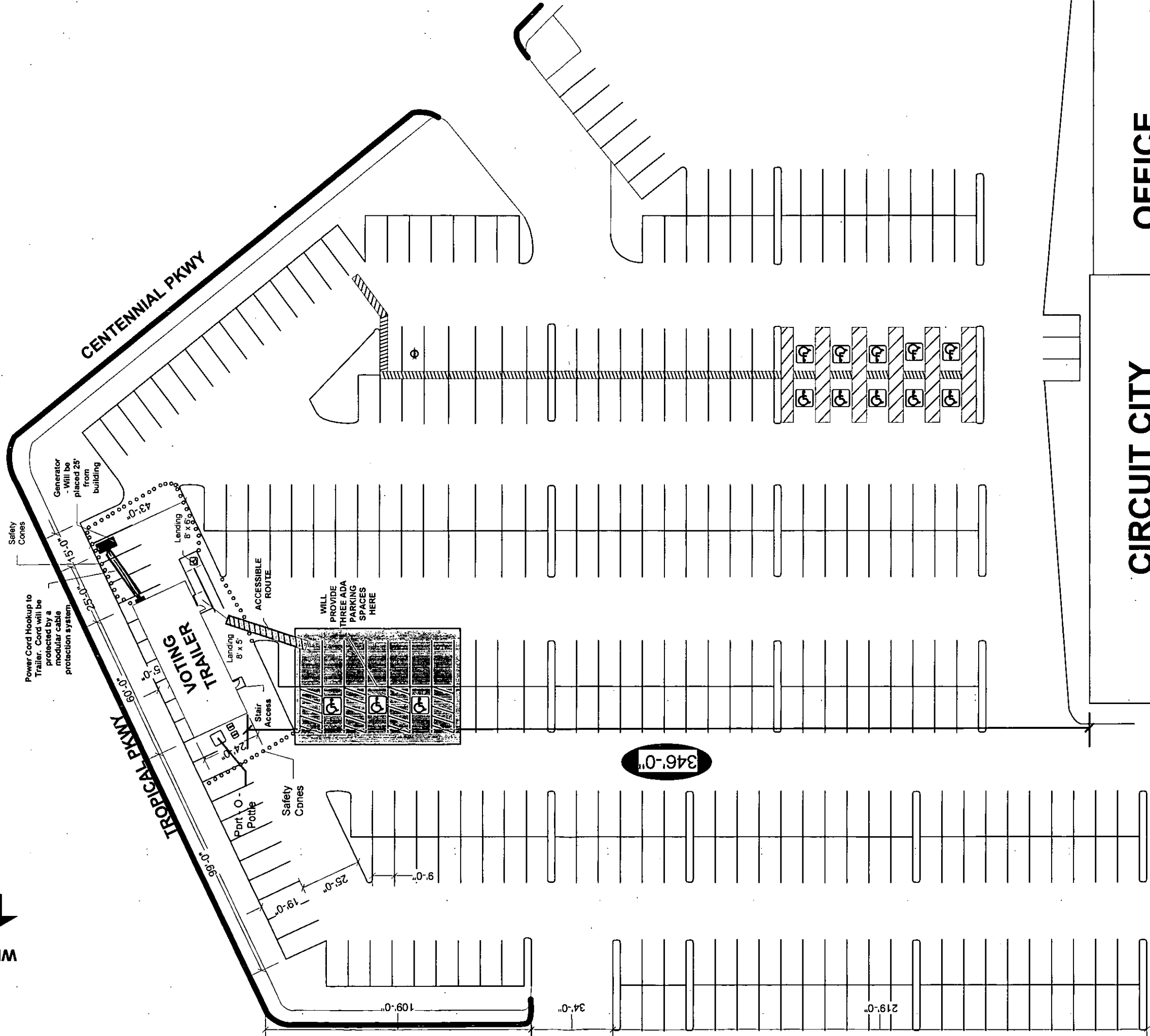

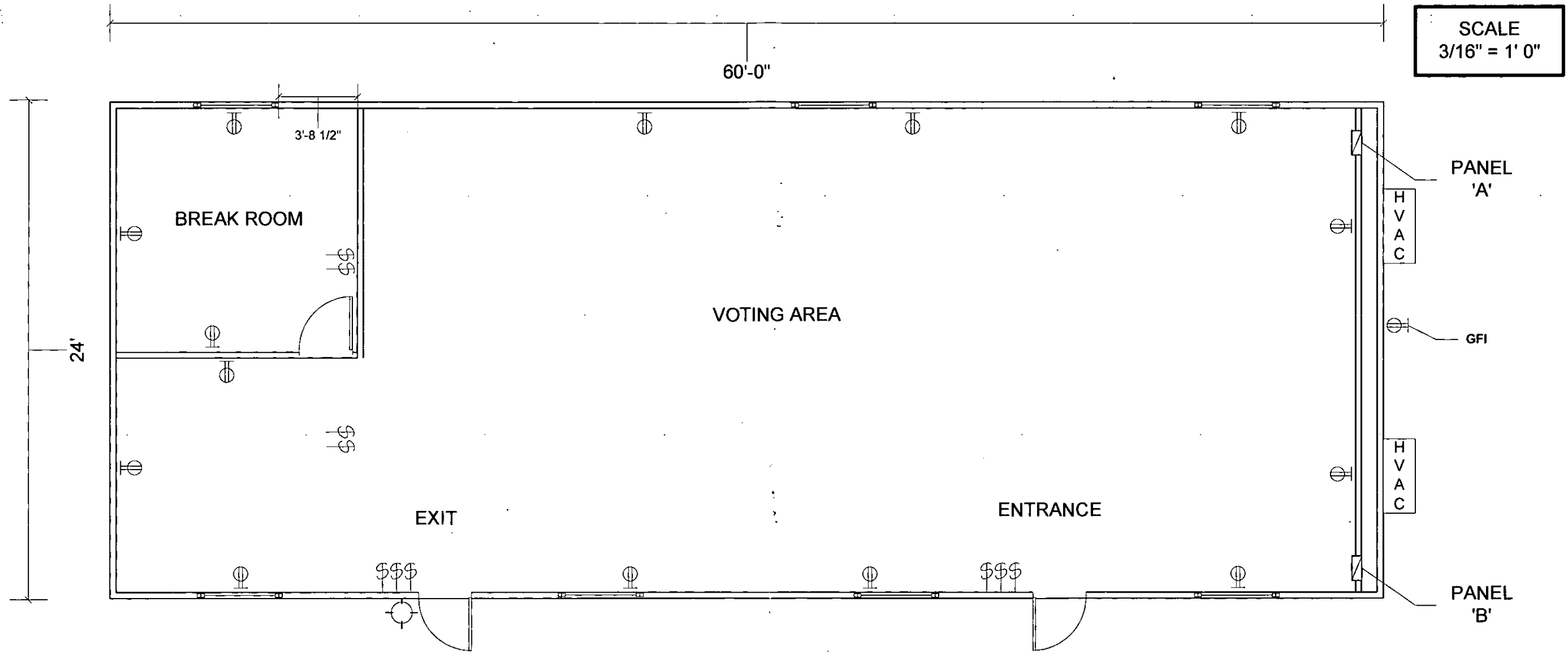

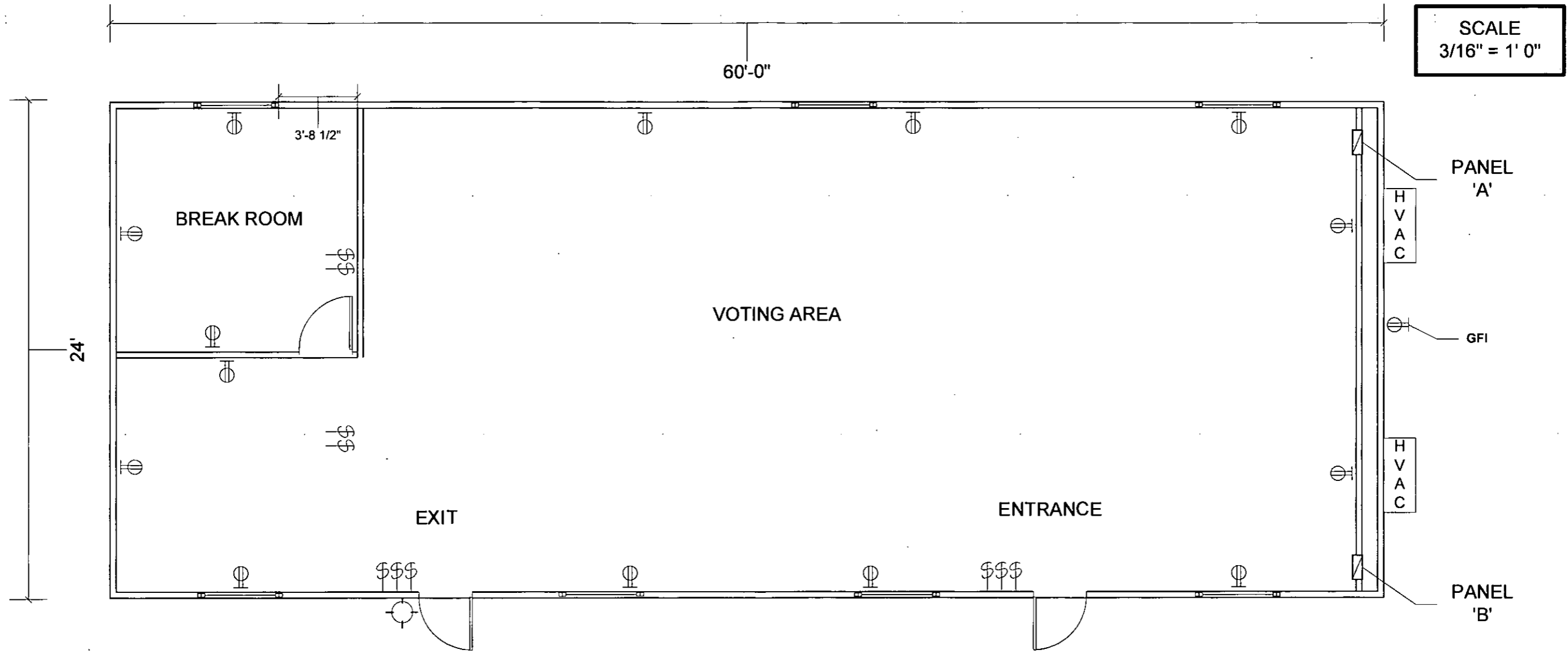
