Description of Sign(s): TSP-47703 - Temporary Sign Permit - 8300 West Cheyenne Avenue Suite 106 - Urgent Care will place two 15-foot tall 'feather banners' within the landscape buffer adjacent to Cheyenne Avenue which reads "Urgent Care" and place one 4X9 Vinyl Banner on the building. The 4X9 banner will be displayed on the following dates: January 1-20, and read "Weight Loss"; April 1-21 and read "Physicals", May 1-22 and read "Physicals"; June 1-21 and read "Physicals"; July 1-21 and read "Physicals"; August 1-21 and read "Flu Shots"; August 1-21 and read "Flu Shots"; September 1-20 and read, "Flu Shots"; October 1-21 and read, "Flu Shots" and November 1-22 and read, "Flu Shots." Feather banners will be displayed on these same dates. No other temp sign may be displayed at any other time as this covers the full 180 2013 temporary sign display period allotment.

THIS PERMIT IS APPROVED PURSUANT TO TITLE 19.14.090A OF THE LAS VEGAS MUNICIPAL CODE, SUBJECT TO THE FOLLOWING CONDITIONS:

- 1) THE TEMPORARY SIGN PERMIT SHALL BE VALID FOR 326 DAYS FROM JANUARY 1, 2013 TO NOVEMBER 22, 2013.
- 2) ALL TEMPORARY SIGNS SHALL BE SET BACK FROM ANY STREET INTERSECTION OR DRIVEWAY OR OTHERWISE LOCATED IN ORDER TO NOT CREATE A SIGHT RESTRICTION.
- 3) ALL TEMPORARY SIGNAGE SHALL BE SO LOCATED AS TO NOT CREATE A NUISANCE TO NEARBY PROPERTIES AS A RESULT OF FACTORS SUCH AS EXCESSIVE ILLUMINATION, GLARE, OR NOISE.
- 4) ALL TEMPORARY SIGNAGE SHALL CONFORM TO THE SUBMITTED SITE PLAN.
- 5) THE APPLICANT SHALL DISPLAY A COPY OF THIS TEMPORARY SIGN PERMIT DURING NORMAL BUSINESS HOURS.
- 6) ALL TEMPORARY IMPROVEMENTS MADE TO THIS SITE AND THE ABUTTING STREETS SHALL BE REMOVED UPON EXPIRATION OF THE PERMIT.
- 7) ALL APPLICABLE CITY CODE REQUIREMENTS SHALL BE SATISFIED.
- 8) THE APPLICANT SHALL BE RESPONSIBLE FOR LEAVING THE SITE FREE OF DEBRIS, LITTER, OR ANY OTHER EVIDENCE OF THE SIGNAGE UPON EXPIRATION OF THE PERMIT.
- 9) NO SIGNS SHALL BE LOCATED IN THE PUBLIC RIGHT-OF-WAY.

PLEASE NOTE:

On August 15, 2012, the City Council approved an Ordinance which extends on a temporary basis the display periods for temporary special event signs. Under this Ordinance, temporary special event signs approved between August 16, 2012 and June 30, 2014 may be displayed by the same business license holder on the same lot up to eight times in any one calendar year. The aggregate time of display of such signs shall not exceed one hundred eighty days in any one calendar year.

Unless otherwise extended or modified by ordinance, the display period of temporary special event signs approved on or after July 1, 2014 shall be subject to the applicable calendar-year limitations that would be in effect independent of this Ordinance.

Urgent Care Extra Justification Letter

Fifty percent of our business is due to our visibility from the road. We are submitting this temporary sign permit application to maximize our visibility and in turn be able to provide excellent medical care to the community. We have three main services that we would like to advertise using a temporary banner. For example, in January we want to let people know we offer doctor assisted weight loss, therefore from January 1-22 we would like to have a banner that says, "WEIGHT LOSS" on our building. The other two services are for student physicals and flu shots. Below are the proposed dates with the proposed banner text.

The feather banners are for more consistent use. We would put them out in the morning when our clinics open and take them down at night when we close. The feather banners would say, "URGENT CARE," on them. We would like a feather banner for each street front and would make sure it was at least 15ft away from any right-of-way and that the sign would not obstruct any visibility.
