WHEREAS, the Board of said Agency desires by this Resolution to Augment and Amend the FY 1990-91 Budget of the City of Las Vegas Downtown Redevelopment Agency, pursuant to NRS 354.615 for the purpose of effecting an increase in appropriations,

NOW, THEREFORE, BE IT RESOLVED by the Board of the Agency, at a regular meeting thereof held on the 19th day of June, 1991, that the FY 1990-91 Budget for the General Fund be increased from \$5,356,812 to \$7,176,692, as itemized in Exhibit A, which is attached hereto and incorporated herein, and adjusted to the amount listed, and

BE IT FURTHER RESOLVED that said Augmentation shall become effective upon delivery of a certified copy of this Resolution to the Nevada Department of Taxation.

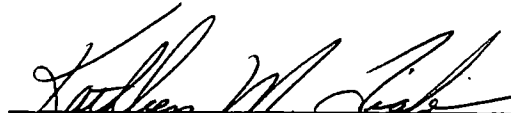
