

2 **RESOLUTION FINDING THE PROJECT TO DEVELOP 11 ACRES COMMONLY KNOWN**
3 **AS "SITE PARCEL B" LOCATED AT THE SOUTHWEST CORNER OF OWENS AVENUE**
4 **AND "H" STREET (APNS 139-28-503-17 AND 139-28-503-005) PROPOSED BY THE WLVD,**
5 **LLC DISPOSITION AND DEVELOPMENT AGREEMENT BETWEEN AND AMONGST**
6 **THE CITY OF LAS VEGAS REDEVELOPMENT AGENCY AND WLVD, LLC AS BEING**
7 **IN COMPLIANCE WITH AND IN FURTHERANCE OF THE GOALS AND OBJECTIVES**
8 **OF THE AGENCY'S REDEVELOPMENT PLAN FOR THE LAS VEGAS**
9 **REDEVELOPMENT AREA AND APPROVING THE EXECUTION OF THE DDA BY THE**
10 **AGENCY AND WAIVE THE REQUIREMENT FOR THE CITIZEN ADVISORY**
11 **COMMITTEE AND CITIZEN EMPLOYMENT ADVISORY COMMITTEE TO CONVENE**

12 WHEREAS, the City of Las Vegas Redevelopment Agency (the "Agency") adopted
13 on March 5, 1986, that plan of redevelopment entitled, to-wit: the Redevelopment Plan for the
14 Downtown Las Vegas Redevelopment Area pursuant to Ordinance 3218, which Redevelopment Plan
15 has been subsequently amended on February 3, 1988, by Ordinance 3339; April 11, 1992, by
16 Ordinance 3637 and on November 4, 1996, by Ordinance 4036 (the "Redevelopment Plan"); and

17 WHEREAS, the Redevelopment Plan identifies and designates an area within the
18 corporate boundaries of the City of Las Vegas (the "Redevelopment Area") as in need of
19 redevelopment in order to eliminate the environmental deficiencies and blight existing therein; and

20 WHEREAS, the Agency is the owner of vacant parcels of land located on Owens
21 Avenue between "H" and "J" Streets in Las Vegas, Nevada, and which parcels are commonly known
22 as APN 139-28-503-005 and APN 139-28-053-017 (the "Site"); and

23 WHEREAS, the Governing Body of the Agency has determined that the Disposition
24 and Development Agreement (the "Agreement"), attached hereto as Exhibit "A" and incorporated
25 herein as a part of this Resolution, which provides for the conveyance of the Site to WLVD, LLC
26 for the development and expansion of a commercial retail center commonly known as Westland Plaza,
27 all as more fully set forth in the Agreement, is in compliance with and in furtherance of the goals and
28 objectives of the Redevelopment Plan; and

WHEREAS, prior to the approval of the Agreement, and after proper publication of
notice thereof, the Agency conducted a public hearing pursuant to the requirements of NRS 279.472;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Governing Board of the
Agency that the Agreement attached hereto as Exhibit "A" is hereby approved and determined to be
in compliance with and in furtherance of the goals and objectives of the Redevelopment Plan, and the

1 Chairperson of the Governing Board of the Agency is hereby authorized and directed to execute the
2 Agreement for and on behalf of the Agency, and to execute any and all additional documents
3 (including any Attachments to the Agreement) and to perform any additional acts necessary to carry
4 out the intent and purpose of the Agreement.

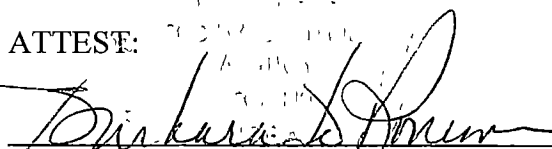
5 RESOLVED FURTHER, that the Agency hereby waives the requirement for the
