

R E S O L U T I O N

1 WHEREAS, the Board of Commissioners of the City of Las Vegas
2 has received a request from the County of Clark, a public agency
3 as defined by Chapter 98, Laws of Nevada, 1957, to lease certain
4 real property owned by the City of Las Vegas, which is not now
5 needed for use by the City of Las Vegas; and

6 WHEREAS, the City of Las Vegas has determined that the said
7 land hereinafter described can be put to a greater public use by
8 the County of Clark,

9 NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
10 OF THE CITY OF LAS VEGAS that it hereby declares its intention to
11 lease the Huntridge Fire Station property to the County of Clark,
12 said property being more particularly described as follows:

13 Lot 2, Block 2 of Huntridge Subdivision Tract 1
14 as shown in Book 2 of Plats, Page 32, and Lots
15 1 and 2, Block 2 of Huntridge Subdivision Tract 2,
16 as shown in Book 2 of Plats, Page 37, and as said
17 lots are shown upon the amendment to the Plats of
18 Huntridge Subdivision Tracts 1, 2 and 3 in Book 2
19 of Plats, Page 63, together with that portion as
20 described by the Order of Vacation in Document 412963
21 recorded September 3, 1953, in the Office of the
22 County Recorder, Clark County, Nevada, shown in
23 Parcel 2 of said Order of Vacation.

19 The rent to be charged the County of Clark shall be Two
20 Hundred Seventy-Five (\$275.00) Dollars per month, and the term of
21 said lease shall be for two (2) years commencing February 15, 1958.

22 BE IT FURTHER RESOLVED that a public meeting of the Board
23 of Commissioners of the City of Las Vegas shall be held on the 5th
24 day of February, 1958, at which meeting objections to the entering
25 into of the proposed lease may be made by the electors of the City
26 of Las Vegas.

27 BE IT FURTHER RESOLVED that the following notice, to-wit:

will consider a lease for two years with the County of Clark for
certain land commonly known as the Huntridge Fire Station, at a
rental of Two Hundred Seventy Five Dollars (\$275.00) per month,
commencing February 15, 1958.
