

**RESOLUTION OF THE CITY COUNCIL REAUTHORIZING THE DIRECTOR OF THE
DEPARTMENT OF PLANNING TO EXTEND ADMINISTRATIVELY A TEMPORARY
BUSINESS LICENSE OF ANY LICENSEE WHO HAS EXHAUSTED ALL APPLICABLE
TEMPORARY-LICENSE EXTENSIONS UNDER TITLE 6 OF THE LAS VEGAS MUNICIPAL
CODE PRIOR TO THE CESSATION OF THE COVID-19 EMERGENCY**

WHEREAS, conditions related to the COVID-19 virus have resulted in a number of negative impacts on businesses; and

WHEREAS, in an effort to provide affected businesses some relief from these impacts, the City Council passed Resolution R-40-2020 on September 2, 2020, which authorized the Director of the Department of Planning to extend administratively, upon application of the licensee and at the Director's discretion until December 31, 2020, the temporary business license of any licensee who exhausted all applicable temporary-license extensions under Title 6 of the Las Vegas Municipal Code prior to the cessation of the COVID-19 emergency; and

WHEREAS, the City Council desires to reauthorize Resolution R-40-2020 in its entirety, including the administrative authority granted therein to the Director of the Department of Planning, from January 1, 2021 through June 30, 2021, to provide relief to businesses affected by the negative impacts of the COVID-19 virus; and

WHEREAS, the reauthorization described herein will allow affected businesses, upon the discretion of the Director of the Department of Planning, to maintain their temporary business licenses if they have exhausted all applicable temporary-license extensions under Title 6 and the current COVID-19 emergency has prevented them from requesting their permanent business license.

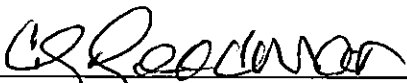

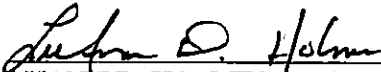
1 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAS
2 VEGAS to reauthorize the Director of the Department of Planning, upon application and at his discretion, to
3 extend administratively a temporary business license of any licensee who has exhausted all applicable
4 temporary-license extensions under Title 6 of the Las Vegas Municipal Code prior to the cessation of the
5 COVID-19 emergency. Any administrative extension of a temporary business license by the Director,
6 pursuant to this Resolution, shall terminate June 30, 2021, or upon the Mayor's Declaration of an end to the
7 current COVID-19 emergency, whichever comes first.

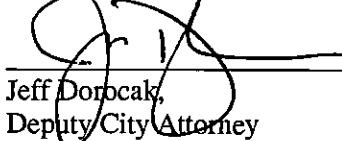
