4. No parking spaces will be taken for this location.

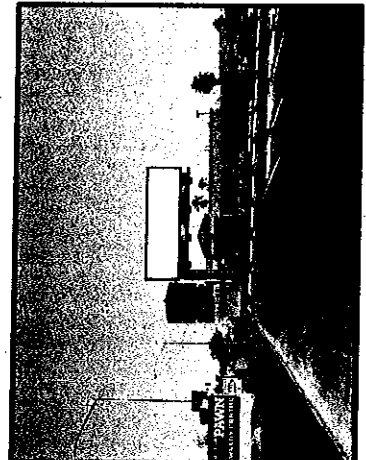

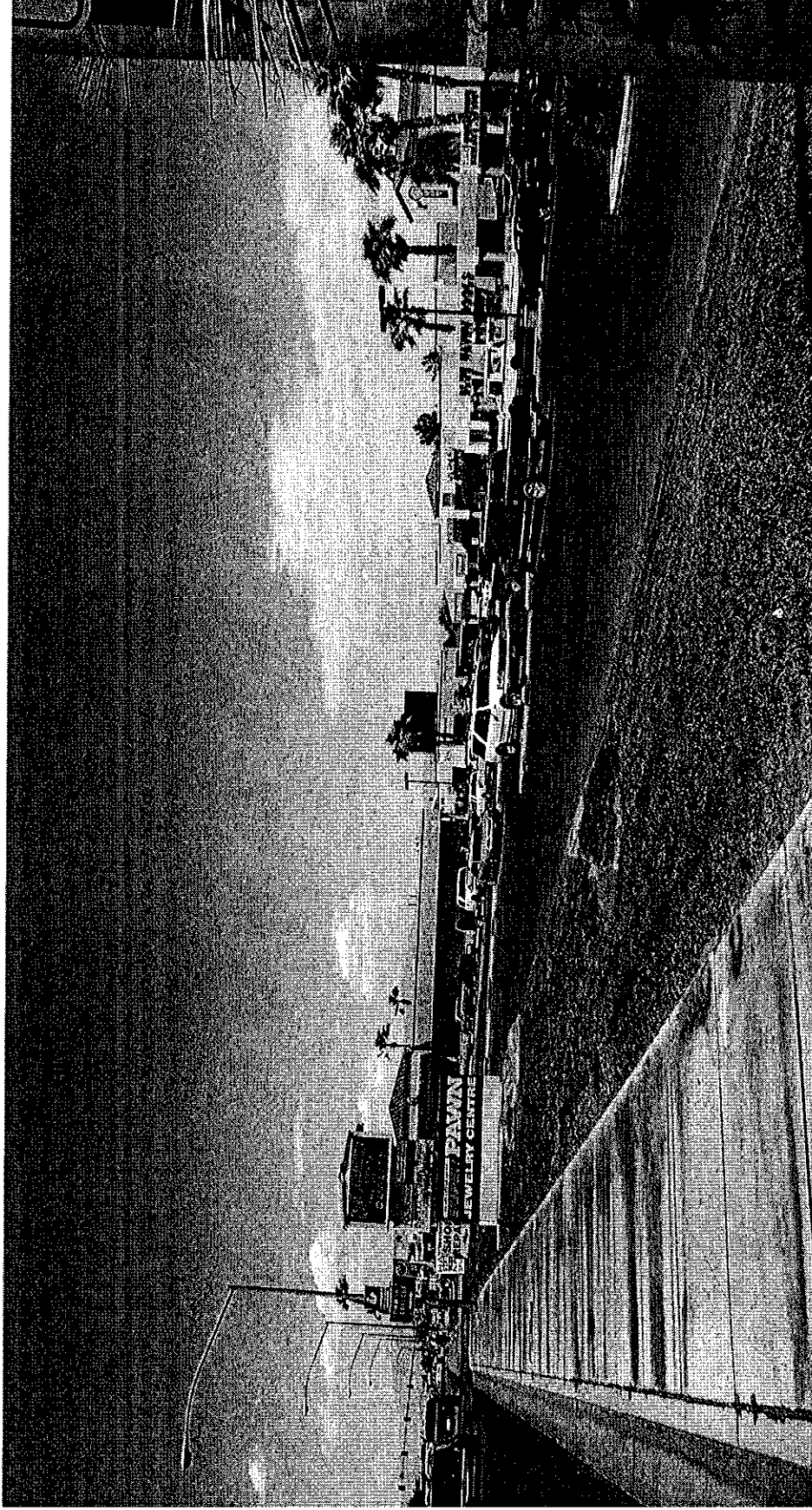

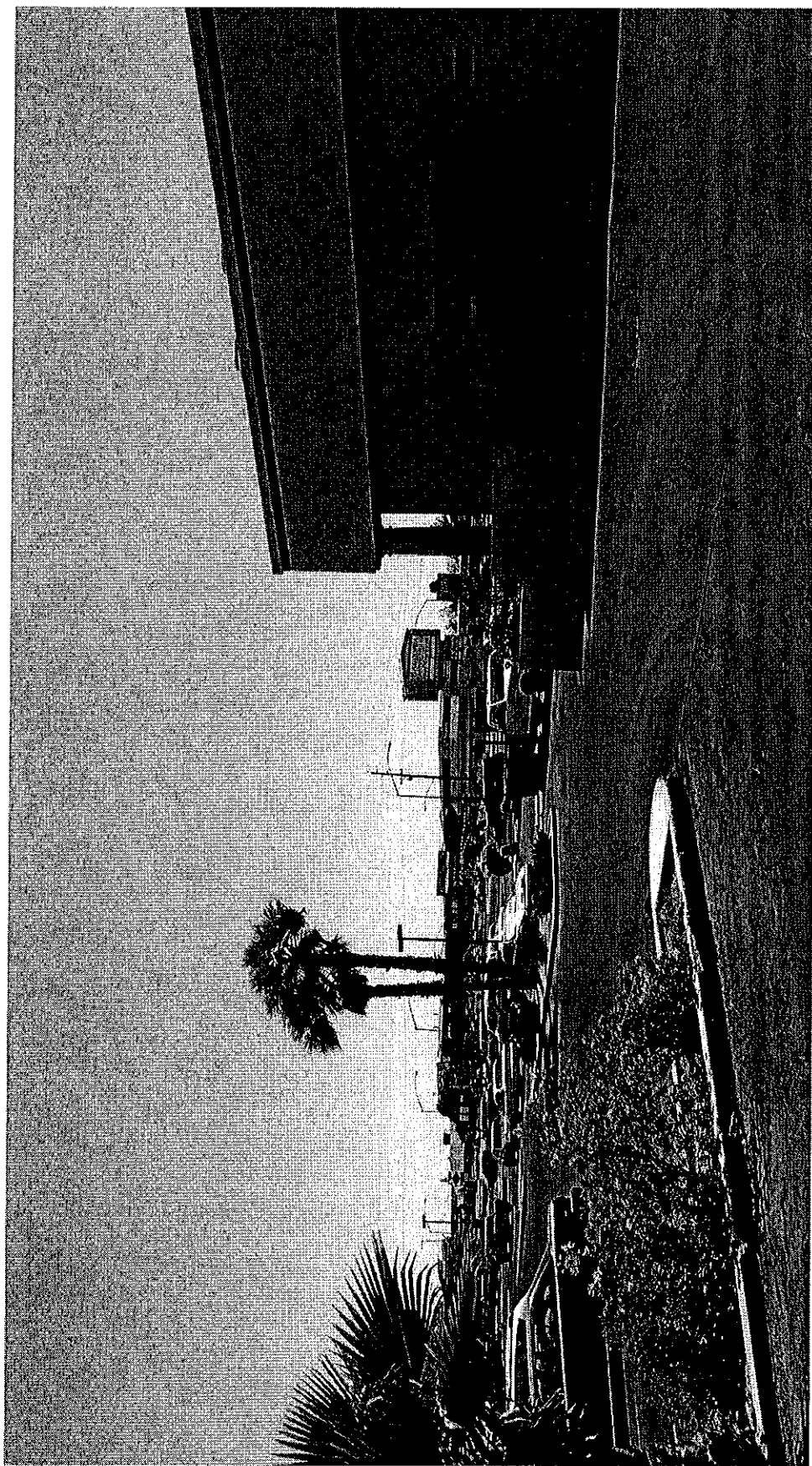
