**PURPOSE/BACKGROUND:**

Donna J. Lawrence d/b/a V.I.P. Massage holds Massage Establishment License No. M03-00137-5-107570, Reflexology Establishment License No. R03-00012-E-107570, and Miscellaneous Services License No. M07-03466-5-107570. Donna J. Lawrence d/b/a V.I.P. Massage has failed to submit a principal for suitability. The masseuses employed at V.I.P. Massage have engaged in acts of prostitution, and given massages with their breasts exposed. Finally, it is alleged that V.I.P. Massage has offered to pay a gratuity to taxicab and limousine drivers in return for delivering customers. Thus, it is submitted that V.I.P. Massage is a nuisance and has been conducted in an unlawful, illegal and impermissible manner.

Revocation of Massage Establishment License No. M03-00137-5-107570, Reflexology Establishment License No. R03-00012-E-107570, and Miscellaneous Services License No. M07-03466-5-107570.
