Dear Jim:

We request Temporary Liquor and Gaming Licenses for Huntridge Shopping Center, LLC (the "Company") dba O'Aces Bar & Grill at the location of 3003 North Rainbow Blvd., Las Vegas, Nevada. The Company is planning to take over the location upon licensing approval from the Nevada Gaming Commission ("NGC"). The application is scheduled for the Gaming Control Board ("GCB") and NGC October 2006 agendas.

In lieu of providing SCOPES on the two principals, Paul L. Kellogg III and Bert P. Woywod, please consider the following as criteria for determining preliminary suitability:

1. Huntridge Shopping Center, LLC is applying at two (2) locations:
 - A. 3003 North Rainbow Blvd., Las Vegas, NV
 - B. 4995 S. Decatur Blvd., Las Vegas, NV

Investigations are currently being conducted by the GCB, Clark County, City of Las Vegas, and Las Vegas Metropolitan Police Department.

2. Paul L. Kellogg, III and Bert P. Woywod have held privileged licenses for many years:

A. From 1986 to 2002, Paul was approved for a Restricted Gaming License in connection with The Lee Motel.

B. On December 20, 1991, Paul and Bert were approved for a Nonrestricted Gaming License in connection with Aztec Inn Casino Limited Partnership dba Aztec Gold Inn & Casino. Paul sold his interest in January 2001 and Bert sold his interest in May 1992.

C. On May 19, 1994, Paul and Bert were approved for a Nonrestricted Gaming License in connection with Hotel Nevada and Gambling Hall, LTD.

D. In October 2003, Paul and Bert were approved for Five (5) Restricted Gaming Licenses in connection with High Street, LLC dba's:

- (i) Huntridge Tavern
- (ii) Huntridge Drug Store
- (iii) Decatur Drug
- (iv) Decatur Drug Restaurant
- (v) Decatur Liquor.

E. In July 2006, the principals submitted a Nonrestricted Gaming application to the GCB in connection with Prospector Enterprises Ely, LLC dba Prospector Hotel and Gambling Hall. This application is currently under investigation by the GCB.
