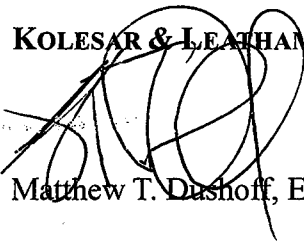
Dear Councilman Wolfson:
