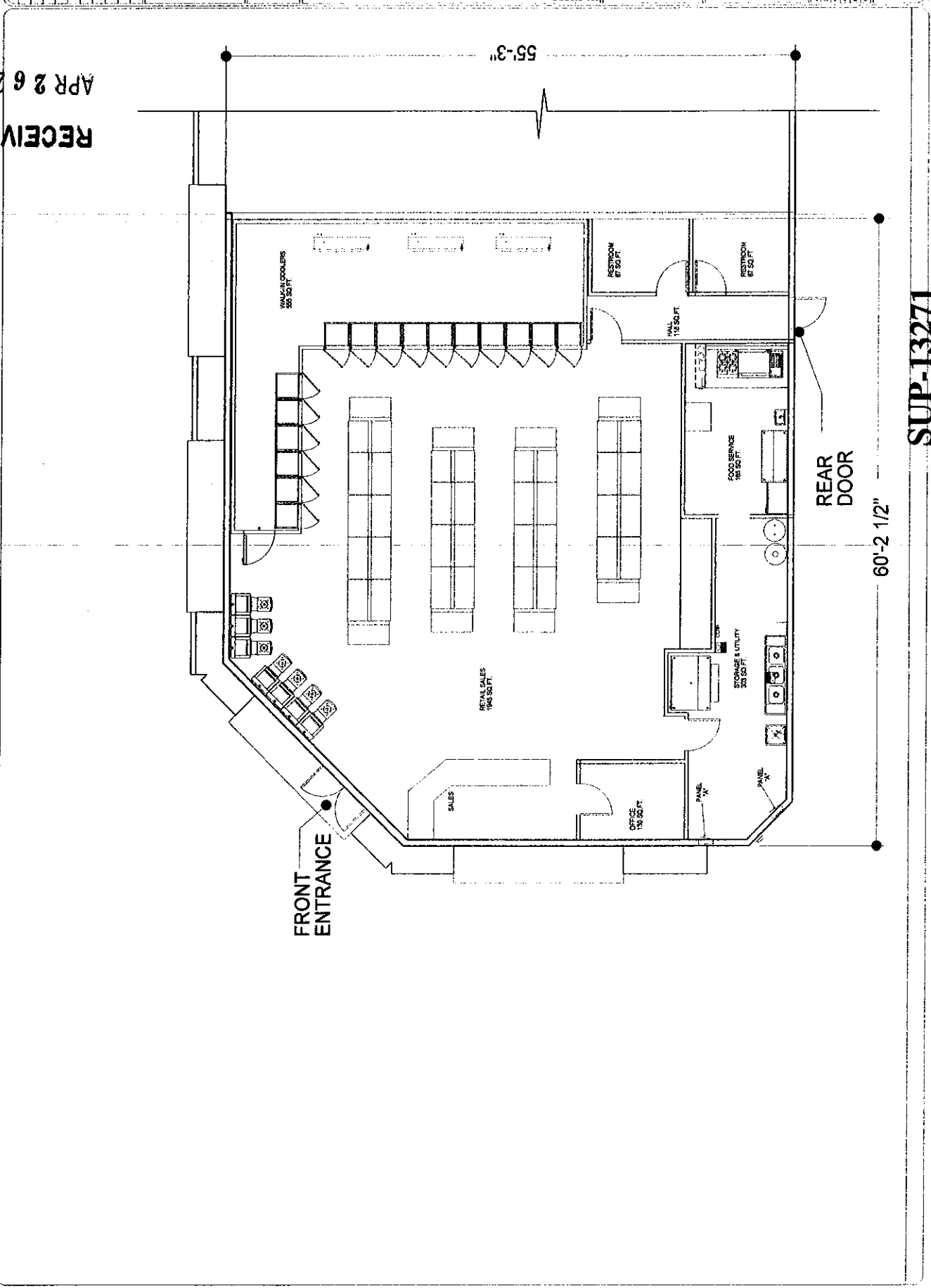


2 vicinity map

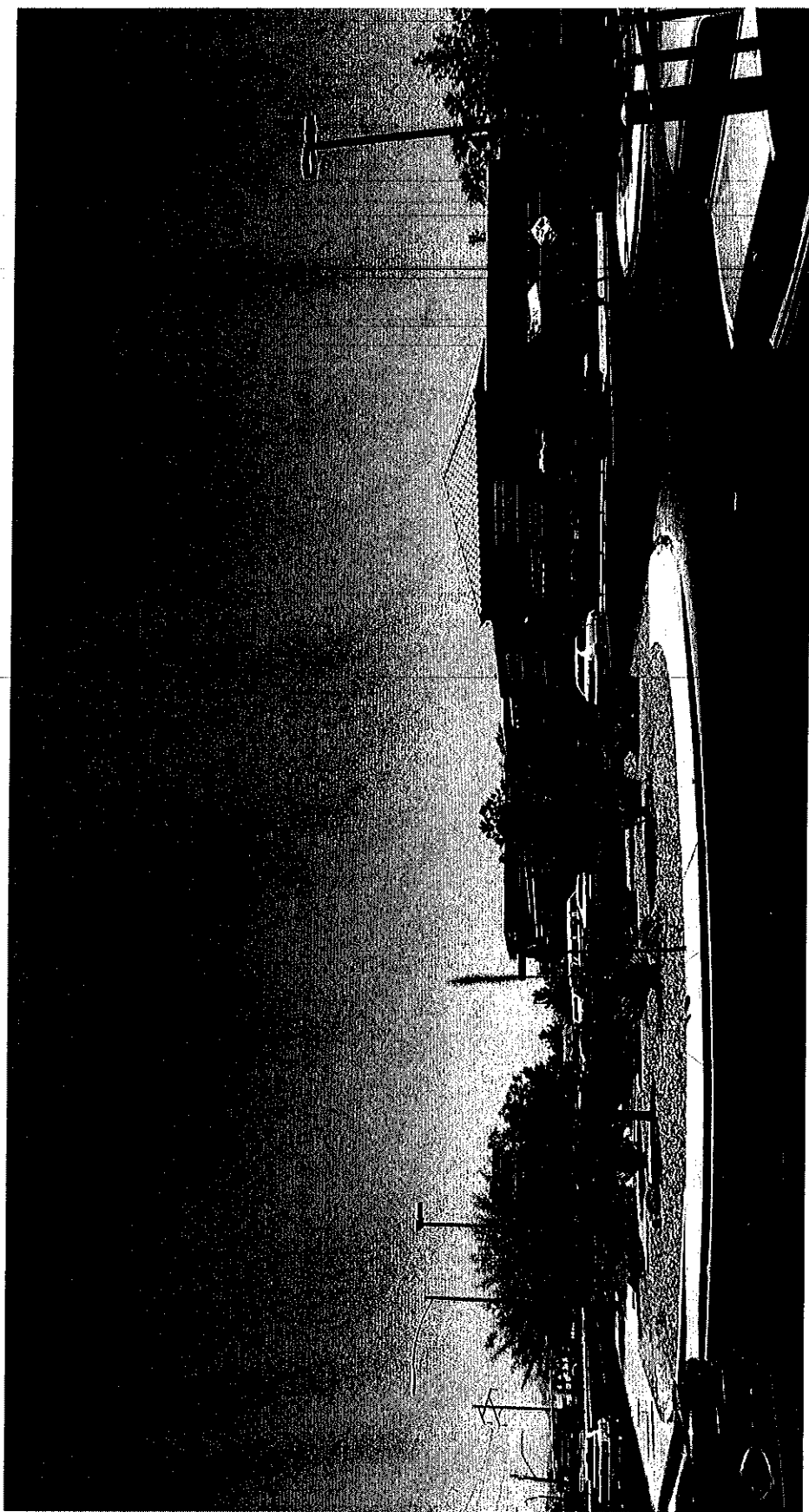

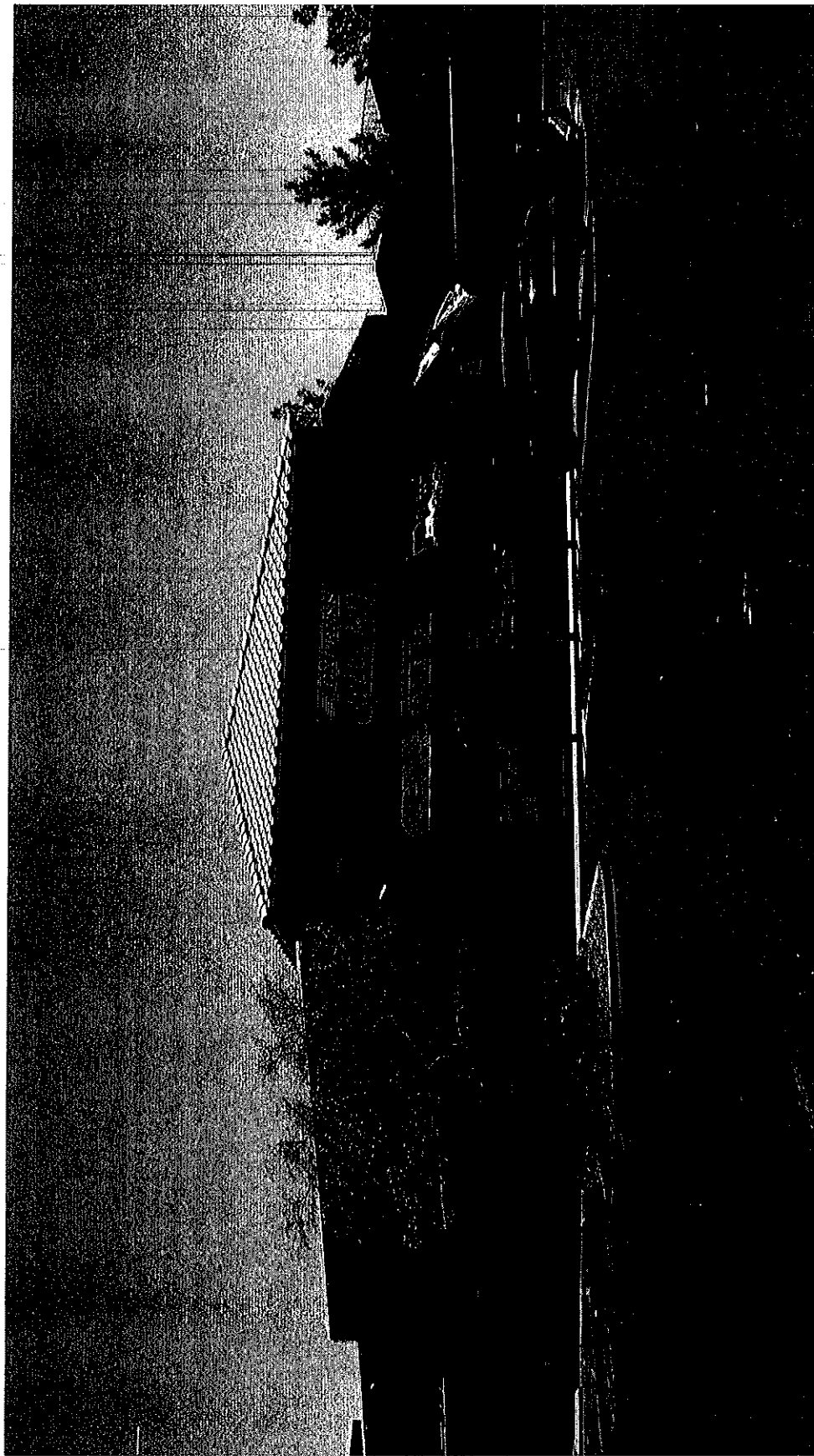

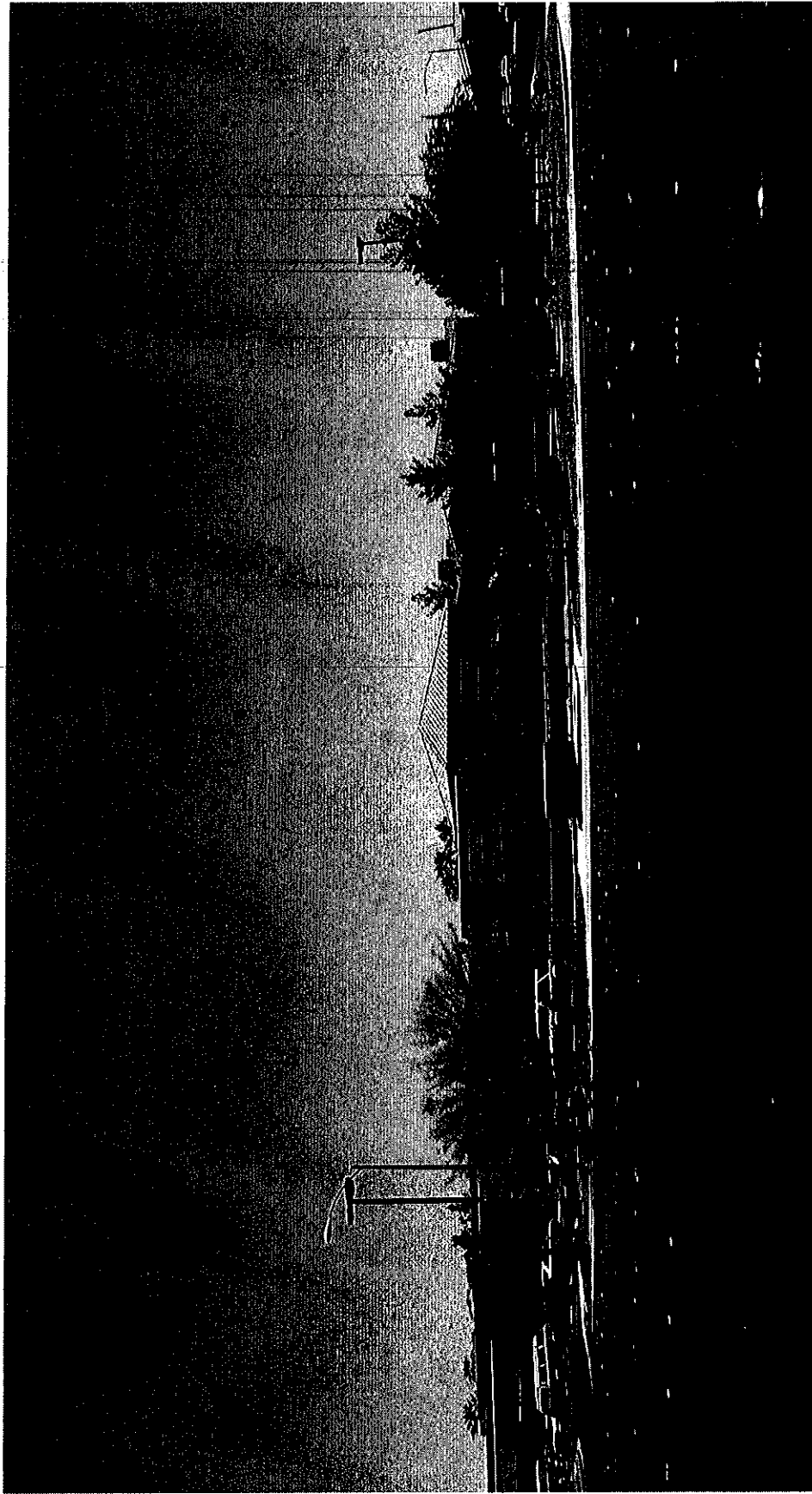
