

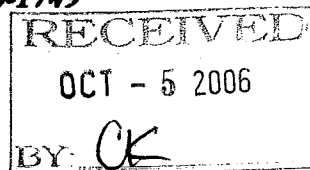

Dear Mr. Henry:

This letter will confirm that, per our request, you had previously rescheduled to October 18, 2006, as the date on which the City Council would hear the Petition for Rehearing by The Power Company, Inc. As you are aware, the deferral was requested so that the City Council could act on the application for a temporary liquor license by The Power Company's prospective sublessee, Michael Signorelli/Nevada Receivership, LLC.

Since the City Council has deferred its decision on the application by Mr. Signorelli on behalf of Nevada Receivership, The Power Company wishes to again defer the hearing on the Petition for Rehearing until after the City Council makes its determination on the application by Mr. Signorelli. If the application by Mr. Signorelli is denied at the City Council meeting on October 18, 2006, The Power Company requests that its hearing on its Petition for Rehearing go forward and be heard at that meeting. If the application by Mr. Signorelli is approved, we would request that the Power Company's hearing be deferred pending opening of business by Mr. Signorelli. If the application is again deferred, The Power Company requests that its hearing be deferred to a date which The Power Company would specify depending on the period for which Mr. Signorelli's application is deferred.
