Dear Owner/Manager:

Congratulations! The Nevada Attorney General's office recently conducted a tobacco compliance check at your store. The details of that compliance check are on the enclosed form. Please review it carefully to answer any questions you may have. Please feel free to give a copy of the form or this letter to all members of your staff.

The Attorney General's office is conducting compliance checks where a citation into justice court will be issued to the clerk who sold tobacco to an underage youth. Since the clerk in your store did not sell tobacco, no citation was issued. When conducting these checks, the underage youth will tell the truth when asked his or her age. If asked for a photo ID, the underage youth may present their own photo ID showing their true age (under 18) or say they do not have one with them or say they do not have one. If the clerk sells a tobacco product to the underage minor, the investigator supervising the compliance check will return to your store and issue a citation to the clerk. This may require interrupting the work routine in your store for a short period of time. Please cooperate with the investigator so that he or she can complete the citation and answer any questions you or your staff may have. Within a reasonable time after the compliance check, you will be mailed a copy of a form reporting the results of the compliance check. The maximum fine for selling tobacco to a minor is \$500 plus court costs. The local justice of the peace will make the decision on the amount of the fine.

Further, I enclose a one-page, two-sided WE CARD flyer briefly describing practical suggestions for checking drivers licenses and other photo ID's. You may want to copy this flyer and distribute copies of it to each of your employees. If you have any questions or suggestions for me, please call me at 775-688-1818. Thank you for your assistance.
