PURPOSE/BACKGROUND:

This project provides for sewer rehabilitation and consists of rehabilitation of 45", 48" and 51" diameter concrete sanitary sewer pipe using cured in place trenchless lining technology, removal and replacement of existing sewer pipes and related work. Work will be accomplished on Sahara Avenue from Arden Street to Nellis Blvd, Nellis Blvd from Sahara Avenue to Vegas Valley Drive and east to Stephanie Street. The bid submitted by Spiniello Companies is deemed non-responsible and is being recommended to rejection. According to the State Contractors Board in order to perform this project a General Contractor must have an "A" or "A15" contractor's license. Spiniello Companies has an "A19A" contractor's license which is unacceptable for this project and is therefore deemed non-responsible.
