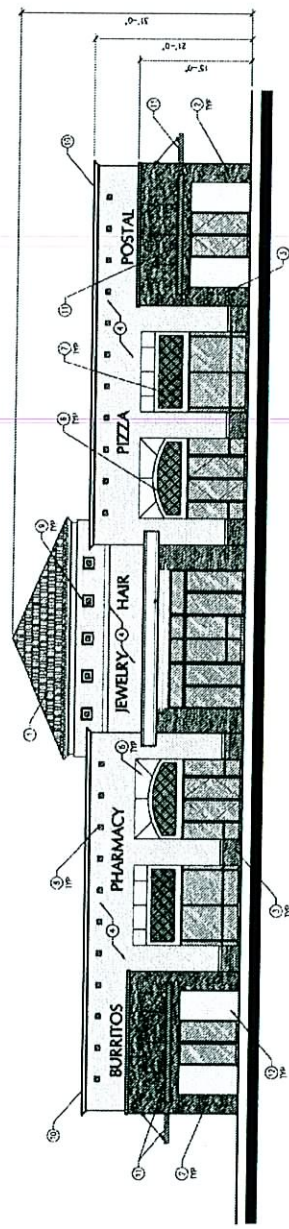




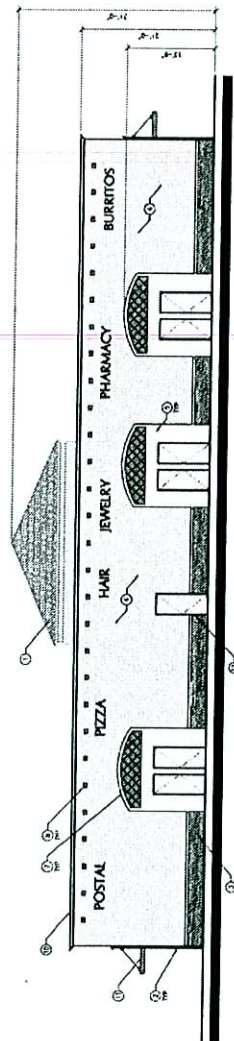
'B' SOUTH ELEVATION
