On behalf of my client, Clear Channel Outdoor, I respectfully request that the above-referenced applications, currently scheduled to be heard by the City Council on Wednesday, November 1, 2006, be held until the Council's next November meeting.

We request this two week continuance to enable us to further investigate and discuss with our engineers alternatives to the conditions requiring a "final inspection" of all existing billboards - via historical documentation or new building permit -which we are discussing with the City Planning Department, the City Building Department, and Lamar Outdoor.

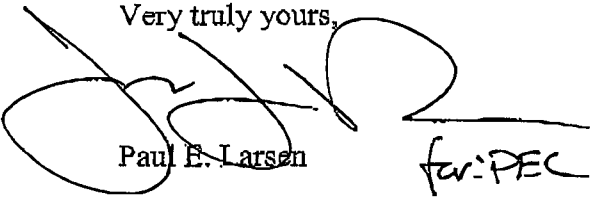
