**RESOLUTION CONSENTING TO CERTAIN UNDERTAKINGS OF THE CITY OF LAS VEGAS REDEVELOPMENT AGENCY IN CONNECTION WITH THE COMMERCIAL VIP AGREEMENT (“CVIP”) WITH LAS VEGAS GROUP, LLC D/B/A WESTERN EXTERMINATOR, INC. FOR THE PROJECT CONCERNING THE DEVELOPMENT OF IMPROVEMENTS TO REAL PROPERTY DESCRIBED AS APN 162-04-608-009**

WHEREAS, the City of Las Vegas Redevelopment Agency (the "Agency") adopted on March 5, 1986, that plan of redevelopment entitled, to-wit: the Redevelopment Plan for the Downtown Las Vegas Redevelopment Area pursuant to Ordinance 3218, which Redevelopment Plan has been subsequently amended on February 3, 1988, by Ordinance 3339; April 11, 1992, by Ordinance 3637, on November 4, 1996, by Ordinance 4036, on December 17, 2003, by Ordinance 5652 and on May 17, 2006, by Ordinance 5830 (the "Redevelopment Plan"); and

WHEREAS, the Redevelopment Plan identifies and designates an area within the corporate boundaries of the City of Las Vegas (the “Redevelopment Area”) as in need of redevelopment in order to eliminate the environmental deficiencies and blight existing therein; and

WHEREAS, the Agency approved on October 20, 2004 the form for the Commercial VIP Agreement, the Commercial VIP Affidavit, and the Commercial VIP Program Manual, in order to provide funding to owners of commercial properties located within the Redevelopment Area for the purpose of making improvements to the exterior of such commercial properties; and

WHEREAS, LAS VEGAS GROUP, LLC D/B/A WESTERN EXTERMINATOR, INC. (the “Participant”) is the owner of real property and improvements

1 located at 108 West Wyoming Avenue, and which parcel is commonly known as APN 162-04-  
2 608-009 (the "Site"); and

3 WHEREAS, the City Council of the City of Las Vegas has considered the  
4 findings that the development of improvements to a building, facilities, structures or other  
5 improvements to be located at the Site are of benefit to the Redevelopment Area or the  
6 immediate neighborhood in which the Redevelopment Area is located; and

8 WHEREAS, the City Council of the City of Las Vegas has considered the  
9 findings that no other reasonable means of financing the building, facilities or structures or  
10 other improvements on the Site are available; and

11  
12 WHEREAS, the City Council of the City of Las Vegas has considered the  
13 undertakings of the Agency in connection with the Ownership Participation Agreement (the  
14 "Agreement"), which provides for the contribution of funds to Las Vegas Group, LLC d//b/a  
15 Western Exterminator, Inc. for making physical, visual improvements to the building located  
16 on the Site, all as more fully set forth in the Agreement.

18 NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council of  
19 the City of Las Vegas hereby finds and determines that the development of building, facilities,  
20 structures or other improvements on the Site are of benefit to the Redevelopment Area or the  
21 immediate neighborhood in which the Redevelopment Area is located; and

23 RESOLVED FURTHER, that the City Council of the City of Las Vegas hereby  
24 finds and determines there are no reasonable means of financing those building, facilities,  
25 structural or other improvements on the Site; and

27 RESOLVED FURTHER, that the City Council of the City of Las Vegas hereby  
28 consents to the undertakings of the Agency in connection with the Agreement with Las Vegas

1 Group, LLC d/b/a Western Exterminator, Inc. for the Project concerning the development on  
2 the Site.




