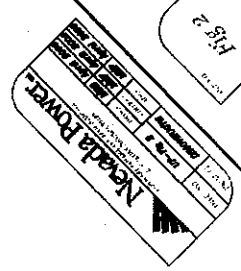
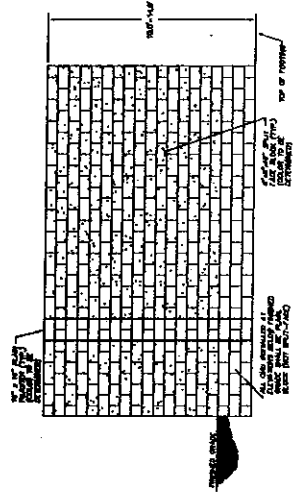

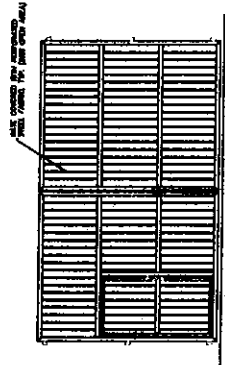

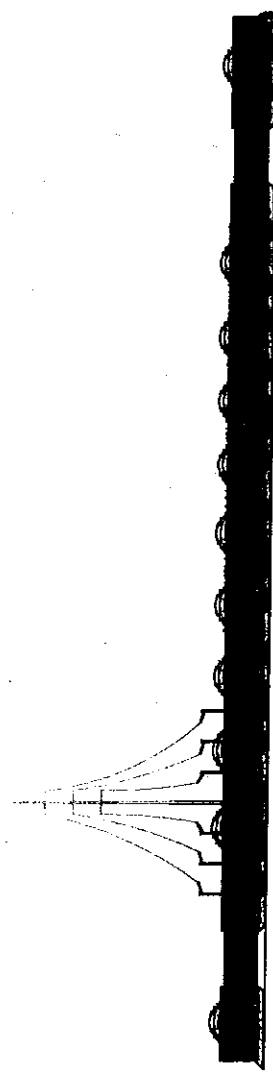


BLOCK WALL DETAIL
NOT TO SCALE

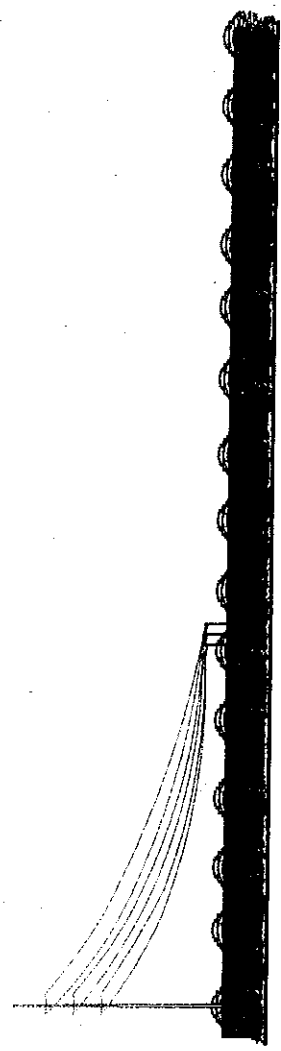

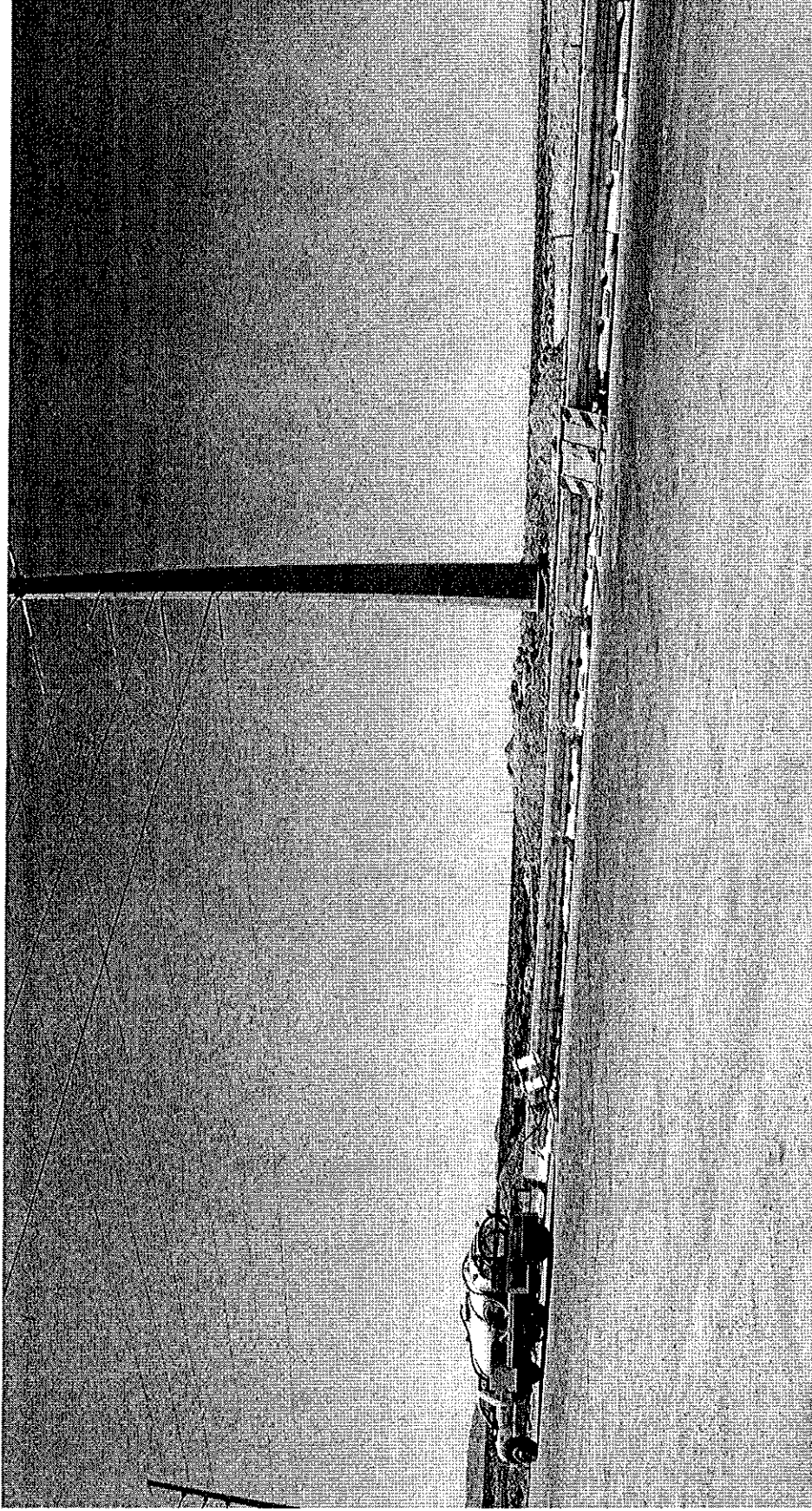
DOUBLE SWING GATE ELEVATION
