I(WE) The CITY OF LAS VEGAS, a municipal corporation of the State of Nevada, for One Dollar and other valuable consideration, do hereby grant and convey to **NEVADA POWER COMPANY** its successors and assigns, the right to construct, to operate, to add to, to maintain, and to finally remove underground electric system(s), consisting of duct lines, manholes, vaults, wires, cables, transformer installation above or below ground surface, service boxes, and other fixtures and apparatus, or any thereof, for the transmission and distribution of electricity and/or communications cable upon, over, under, and across the parcel(s) hereinafter described and the right of ingress and egress to and over the said parcel(s); together with the right to clear and keep cleared any obstruction from the surface or subsurface as may be deemed necessary to insure the safe and proper operation of said electric system(s).

The above referred to parcel of land in the County of Clark, State of Nevada, is that portion of the Northeast Quarter of the Southeast Quarter (NE1/4 SE1/4) of Section 25, Township 20 South, Range 61 East, M.D.B.&M., more particularly described as follows:

Property owner shall not permit the construction or placement of any structures within easement area, including, but not limited to, parking canopies, storage buildings and covered facilities without the written consent of Nevada Power Company.

That portion of the Northeast Quarter of the Southeast Quarter (NE1/4 SE1/4) of Section 25, Township 20 South, Range 61 East, M.D.B.&M., more particularly described as follows:

PARCEL ONE:

COMMENCING at the Northeast corner of said Northeast Quarter of the Southeast Quarter (NE1/4 SE1/4) of Section 25, said point being the intersection of the centerlines of Washington Avenue and Pecos Road, thence along the north line thereof North 89°06'38" West a distance of 169.25 feet; thence leaving said north line South 00°53'22" West a distance of 50.00 feet to a point on the south line of Washington Avenue, said point being the POINT OF BEGINNING;

thence along the boundary lines of said Washington Avenue and Pecos Road the following five courses and distances:

1. South 89°06'38" East a distance of 66.79 feet to a point on a tangent curve concave southwesterly having a radius of 55.00 feet;
2. thence southeasterly along said curve through a central angle of 88°35'56" an arc distance of 85.05 feet to a point on a tangent compound curve concave westerly having a radius of 20.00 feet;
3. thence southerly along said curve through a central angle of 09°27'44" an arc distance of 3.30 feet to a point;
4. thence tangent to said curve South 08°57'01" West a distance of 56.69 feet to a point on a tangent curve concave easterly having a radius of 30.00 feet;
5. thence southerly along said curve through a central angle of 09°27'44" an arc distance of 4.95 feet to a point;

thence leaving said westerly line of Pecos Road South 89°29'17 West a distance of 5.00 feet to a point hereinafter called Point "A";

thence continuing South 89°29'17 West a distance of 5.00 feet to a point;

thence North 00°30'43" West a distance of 60.19 feet to a point;

thence North 05°26'42" West a distance of 26.57 feet to a point;

thence North 35°07'26" West a distance of 23.06 feet to a point;

thence North 86°00'52" west a distance of 9.69 feet to a point;

thence North 89°06'38" West a distance of 75.71 feet to a point;

thence North 00°53'22" East a distance of 12.50 feet to the POINT OF BEGINNING.

Centerline No. 1:

A strip of land 10.00 feet in width lying 5.00 feet on each side of the following described centerline.

**BEGINNING at the above described Point "A", thence South 00°30'43" East a distance of 82.81 feet;
thence South 54°29'57" West a distance of 125.73 feet to a point hereinafter called Point "B", said point being the POINT OF ENDING.**

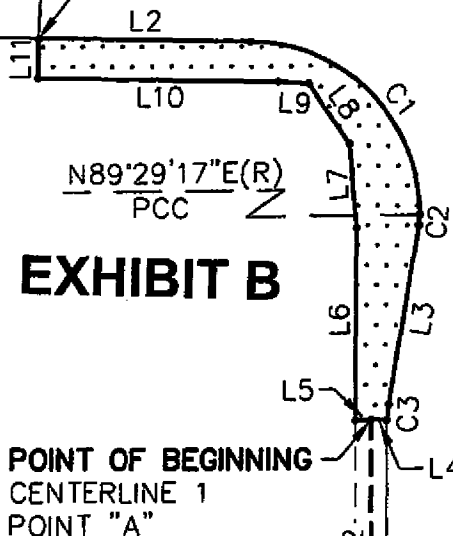
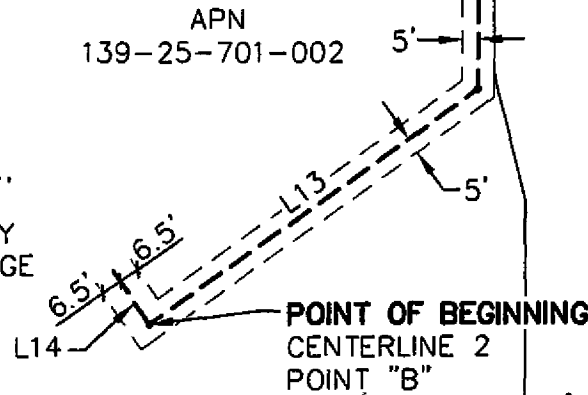

POINT "A"

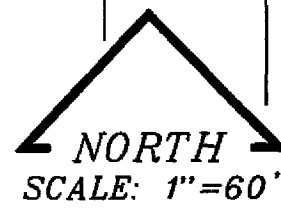
