**PURPOSE/BACKGROUND:**

On January 19, 2005 City Council approved the award of Contract No. 050645 to Berryman & Henegar to provide an engineering design agreement for the design, right-of-way acquisition and construction of a trail system within the Las Vegas Wash corridor from Stewart Avenue to Charleston Boulevard in the amount of \$400,000. This Modification will extend the existing Las Vegas Wash Trail project, which provides for the design, right-of-way acquisition and construction of a trail system within the Las Vegas Wash corridor from Owens Avenue to Stewart Avenue in the amount of \$113,560. Since the initial Contract was approved, the name of the Company has been changed from Berryman & Henegar to Bureau Veritas North America, Inc. This requirement is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
