

**SUPPLEMENTAL NO. 5 TO THE INTERLOCAL CONTRACT FOR  
DURANGO DRIVE, WESTCLIFF DRIVE TO VEGAS DRIVE**

**THIS SUPPLEMENTAL TO THE INTERLOCAL CONTRACT**, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2007 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

**WITNESSETH**

**WHEREAS**, RTC approved an Interlocal Contract on March 14, 2002 and Supplemental Interlocal Contracts dated February 11, 2004, July 8, 2004, May 19, 2005 and July 14, 2005 for a project to design, purchase right-of-way, construction inspection and construct roadway improvements for Durango Drive, Westcliff Drive to Vegas Drive, being located totally within the CITY; and

**WHEREAS**, the RTC previously granted "Authorization to Proceed" for engineering, right-of-way other and construction; and

**WHEREAS**, the CITY wishes to extend the completion date for the project.

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, the RTC authorizes the CITY to proceed with the PROJECT as it is mutually understood and agrees as follows.

**SECTION III – GENERAL, paragraph 7 shall be changed to read as follows:**

7. The project must be completed to the satisfaction of the RTC prior to December 30, 2008. The RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

All other terms of the Interlocal Contract dated March 14, 2002 and Supplemental Interlocal Contracts dated February 11, 2004, July 8, 2004, May 19, 2005 and July 14, 2005 shall remain unchanged.
