Minutes:

MAYOR GOODMAN declared the Public Hearing open for Item 88 [VAR-17998] and Item 89 [SDR-17999].

RON LABAR, Labar Architecture, 458 West 15th Avenue, Spokane, Washington, appeared on behalf of the applicant. They are proposing to tear down the existing Taco Bell at Charleston Boulevard and Decatur Boulevard and replace with a newer, smaller building. Originally they wanted to remodel the restaurant, but found out through the permit process that they would have

to dedicate a 10 foot right-of-way along Decatur Boulevard for a right-turn lane. By doing that, the existing site would not be feasible to use. They have worked with the Nevada Department of Transportation (NDOT) to address traffic concerns. The building will meet the needs for this area.

MAYOR GOODMAN pointed out that this particular location was one of the most successful Taco Bell locations in the world. MR. LABAN added that it still does well, particularly with the super center.

COUNCILWOMAN TARKANIAN stated she is looking forward to the new Taco Bell.
