**PURPOSE/BACKGROUND:**

The Historic Preservation Commission is comprised of members filling nine different categories. Terms are for four years, with no limit to the number of terms that may be served. Mr. Aikens (representing the Category 4 member, Experienced in Real Estate Profession) has served one term. He is eligible and wishes to be reappointed. Ms. Janet Ruth White (representing Category 7, Citizen-At-Large) has served one full and one partial term. She is eligible and wishes to be reappointed..

Commissioner Bob Stoldal, Chairman of the Historic Preservation Commission, recommends the following: Reappoint Mr. Aikens; and Appoint Mr. Greg Seymour to fill Category 7, Citizen-At-Large, to provide an archaeological element on this Commission.

**RECOMMENDATION:**
