PURPOSE/BACKGROUND:

The proposed ordinance annexes certain property generally located on the north and south sides of I-215 (Clark County Highway 215) between Shaumber Road and Fort Apache Road. The annexation is at the request of certain property owners and the City, with a statement of non-objection having been filed by the Bureau of Land Management as an additional owner. The annexation process has now been completed in accordance with the NRS and the final date of annexation (February 16, 2007) is set by this ordinance.
