**PURPOSE/BACKGROUND:**

On January 4, 2006 City Council approved the award of a Contract in the amount of \$208,000 to provide consulting and training services to facilitate a work standards process team at the Water Pollution Control Facility to develop work standards documentation. On July 12, 2006 City Council approved the award of Modification No. 1 that added services to develop electrical instrumentation, HVAC work guidelines and an implementation plan. This Modification adds services to develop work guidelines and an implementation plan for the Operations area. This Modification is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
