PURPOSE/BACKGROUND:

This project consists of the geotechnical investigations, surveying, right-of-way determinations, project design, feasibility studies and cost estimates of four pedestrian bridge structures. Pedestrian bridge structure locations may vary depending on the outcome of the alignment study. The tentative locations are: Las Vegas Wash Trail/Lamb Boulevard crossing, Las Vegas Wash Trail/Charleston Boulevard crossing, Lone Mountain Trail/Cheyenne Avenue crossing and Lone Mountain Trail/Lake Mead Boulevard crossing. This Agreement is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
