Las Vegas City Employees Association (LVCEA), Nevada Supreme Court Case No. 47702, if other NBS parties to the Nevada Business Services (NBS) interlocal agreement legally authorize their contractually required sums - All Wards

PURPOSE/BACKGROUND:

LVCEA has alleged that NBS and the City of Las Vegas have breached their contract with it requiring written notice of a reduction in force. LVCEA brought a complaint to the Employee-Management Relations Board (EMRB) and prevailed. LVCEA brought the complaint against NBS as the employer, and the City of Las Vegas because it had the management services contract. LVCEA chose not to name the other signatories to the interlocal agreement, and the rules of the EMRB and the Administrative Procedure Act do not provide for joining third parties. The City and NBS sought judicial review and lost. The matter is before the Nevada Supreme Court and an offer to settle in the amount of \$650,000 has been made by LVCEA.
