Commissioner Janet Ruth White's term on the Historic Preservation Commission will expire on March 6, 2007. Terms are four years, with no limit to number of terms. To date, Commissioner White is eligible for reappointment.

Ms. White replaced Richard Segerblom in 2001, so she has served one partial plus one full term. She currently fills a Category 7, Citizens-At-Large, position on the commission.

On February 7, 2007, City Council approved the reappointment of Commissioner Aikens, and held the reappointment of Commissioner White in abeyance until the February 21, 2007 City Council meeting. Commissioner White has expressed a desire to be reappointed. Ms. White's record of meeting attendance is attached to this memo.

On January 9, 2007, Chairman Robert Stoldal, on behalf of the Historic Preservation Commission, submitted a letter to the City Council recommending that Mr. Aikens be reappointed, and that Gregory Seymour be appointed for Category 7, Citizen-At-Large.
