

**SUPPLEMENTAL NO. 3 TO THE INTERLOCAL CONTRACT FOR
BUFFALO DRIVE, CHEYENNE AVENUE TO LONE MOUNTAIN ROAD**

THIS SUPPLEMENTAL TO THE INTERLOCAL CONTRACT made and entered into this 12th day of MARCH, 2007, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as the CITY and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as RTC.

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on November 13, 1997 and Supplemental Interlocal Contracts dated August 8, 2002 and November 4, 2002 for a project to design, purchase right-of-way, perform construction inspection and construct roadway improvements for Buffalo Drive, Cheyenne Avenue to Lone Mountain Road located partially within the CITY and partially within the COUNTY; and

WHEREAS, the RTC previously granted "Authorization to Proceed" for engineering, right-of-way other, right-of-way acquisition and construction; and,

WHEREAS, the CITY desires to extend the completion date for the Project.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION III - GENERAL, paragraph 7 shall be changed to read as follows:

7. The Project must be completed to the satisfaction of the RTC prior to December 31, 2008. The RTC may, at any time thereafter, grant time extensions or terminate this Contract and require all sums advanced to the CITY be repaid.

The remainder of the Interlocal Contract approved by the Regional Transportation Commission remains unchanged.






