Minutes:

JIM DiFIORE, Manager of Business Services, stated that there were concerns regarding minors in the bar and employees not possessing required alcohol awareness cards. However, calls for service have been minimal, and MS. MILTON has worked to comply with the codes. She is in the process of finding a new business location. He recommended approval of a permanent license, subject to six-month review, with the caveat that any new location would have to be reviewed by the Council.

Before moving on to the next item, MAYOR GOODMAN announced that COUNCILMAN REESE would be the spokesperson for matters involving Ward 5 until a representative is

appointed, on an interim basis, within 30 days of COUNCILMAN WEEKLY'S resignation, or the designation of a special election within 30 days. KARLETTE ADAMS, Ward 5 Sr. Executive Secretary, would be receiving calls and forwarding them to COUNCILMAN REESE. ANTHONY SNOWDEN, AL GALLEGO, BEATRICE TURNER and DOROTHY BARNES complained about the City not complying with the City Charter and insisted the Mayor appoint someone to represent Ward 5 residents.

TED RUSSELL advised that any of the previous speakers who have a problem with the Mayor's comments could visit the Law Library at 303 North Third Street.
