**Minutes:**

JIM DiFIORE, Manager of Business Services, indicated that MR. YOUNG was back for final review. MR. YOUNG has been successful in complying with business codes. MR. DiFIORE recommended permanent approval of the position for canteen manager, with the original conditions: 1) improved security for the outside of the club, with alcohol prohibited in the parking lot; 2) improved lighting for the parking lot; 3) staff maintain appropriate alcohol, health and work cards; and 4) closing be no later than 9:30 p.m. for service of alcohol and 10:00

p.m. for closing of the club. He also requested a six-month review of the circumstances and conditions.

MR. YOUNG requested the hours be extended to 11:30 p.m. for service of alcohol and to 12:00 a.m. for closure of the club, noting that he has complied with the conditions and the club is currently operating in the red. MR. DiFIORE conceded that there have been no problems in the past six months; however, he advised that many of the problems occur during late hours. Therefore, he requested his proposed six-month review be changed to a 60-day review, should the Council opt to extend the hours.

COUNCILMAN REESE clarified with MR. YOUNG that he would like to stop serving alcohol at 11:30 p.m. and close the club at 12:00 a.m.
