Abatement of the property by removing refuse, waste, trash, debris, vegetation (including dead bushes, trees, ground covering and trimming low hanging tree limbs), securing doors/windows, openings that are open/accessible or openings not boarded to City of Las Vegas specifications, securing rear property line with minimum 6 foot chain link fence, removing shed from rear of property and post "No Vehicles, No Trespassing and No Dumping" signs on property located at **1405 S. CASINO CENTER BOULEVARD**, legally described as **BOULDER ADD, PLAT BOOK 1 PAGE 52 LOT 2 & LOT 3 BLOCK 16**. Owner of record at time of abatement: **MARTIN TODD GROUP – WARD 3 (REESE)**

The Director of Neighborhood Services certifies in the report that the sum of \$6,472.85 was expended (\$4,369.00 for cleaning and repair by C. H. Construction; and \$148.50 for Re-inspection fees; \$655.35 Administrative Processing Fee and \$1,300.00 in civil penalties).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
