NOTE: COUNCILWOMAN TARKANIAN asked CITY ATTORNEY JERBIC if she should abstain because she has received campaign contributions from ATTORNEY BROWN. CITY ATTORNEY JERBIC opined that there is absolutely no legal requirement for her to abstain because of a campaign contribution; however, she could abstain if she felt her objectivity would be clouded by the fact she received a contribution. He added that this has been addressed by the State Ethics Committee. Consideration should be given to abstention only on any matters wherein a sizeable contribution is made. COUNCILMAN REESE confirmed that disclosure is not necessary every time an applicant who has made a contribution appears.

### Minutes:

JIM DiFIORE, Manager of Business Services, reported the six-month review was requested by former COUNCILMAN WEEKLY. There were initial conditions imposed, and there have been 20 minimal calls for service at this location, however, only one was of issue. There was a fatality in the parking lot, but the police department indicated it was not related to the business. He suggested another six-month review, with the same conditions, for the new Councilmember to review the operation of the business.
