PURPOSE/BACKGROUND:

This request will allow the Purchasing and Contracts Manager to sign an agreement for the lease of two experimental hydrogen engine vehicles from Ford Motor Company to be used by the CLV Staff for the purpose of evaluating alternative fuel vehicles. Funding for the lease of these vehicles is supported by a Department of Energy grant. The Agreement includes an indemnification provision in section 7(d), which requires City Council approval.

LARRY HAUGSNESS, Director of Field Operations, stated the two hydrogen vehicles will be used mainly for the shoppers express route in the downtown area. They will supplement the existing fleet at no cost to the City. The lease is for two years, and it is reimbursable by the Federal government. He thanked DAN HYDE for pursuing the acquisition. He recommended approval.

TOM McGOWAN, Las Vegas resident, asked who would guarantee the safety of the hydrogen fuel engines, to which MR. HAUGSNESS replied that the National Safety Transportation Board inspects the vehicles.
