Thank you for all that you have done for our fine city in the 7 years that my wife and I have lived in McNeil Estates; just across the way from you. I love our neighborhood and surrounding area and consider it among the most enjoyable enclaves in the entire city.

As your honor is also quite aware, our proximity to McCarran makes for fairly frequent, yet mild aviation noise, when planes take off and land on McCarran's North/South runways. This does not bother the vast majority of the people that live in our neighborhood and these planes are at approximately 2,500 feet when they pass over, so I'm a bit confused by Summerlin and the City's objections to the "right turn", when the planes are at approximately 5,000-5,500 feet when passing over their community. YOU CAN BARELY HEAR THEM! The "right turn" is best for airport operations, which is ok by me, since I'm a frequent flyer and understand that getting in and out of McCarran with a minimum of delay is very good business for the City and Clark County.
