**PURPOSE/BACKGROUND:**

On July 18, 2001 Council approved the award of an Agreement with BAUGHMAN & TURNER, INC. and on January 8, 2003 Council approved the First Amendment to add hardscape and landscape elements to the project. The Second Amendment represents additional owner requested design changes to replace two (2) 10-inch diameter sewer lines in Stewart Avenue between Main Street and 8th Street with an 18-inch diameter sewer lines, additional replacement of pavement on Stewart Avenue from Main Street to Maryland Parkway, development of the Stewart Avenue utility corridor, and additional related services not included in the original contract or previous amendment in the amount of \$294,205, bringing the total amount to \$593,971.
