PURPOSE/BACKGROUND:

The Historic Preservation Commission is comprised of members filling nine different categories. Terms are for four years, with no limit to the number of terms that may be served and unexpired must be filled, if appropriate. Mr. Kirk (representing Category 5 - Representative of a Recognized Local Historic Preservation Association or Historic Preservation Interest Group seat) has resigned. This appointment will be effective June 18, 2007.

The Planning Department and Commissioner Bob Stoldal, Chairman of the Historic Preservation Commission, recommends Mr. Greg Seymour to fill this seat.
