The City Council at a regular meeting held June 1, 2005 APPROVED the request for a Variance TO ALLOW A R-PD (RESIDENTIAL PLANNED DEVELOPMENT) ZONING DISTRICT ON 1.79 ACRES WHERE 5.00 ACRES IS THE MINIMUM REQUIRED adjacent to the north side of Centennial Parkway, approximately 310 feet east of Leon Avenue (APN 125-24-404-007); R-E (Residence Estates) Zone [PROPOSED: R-PD4 (Residential Planned Development - 4 units per acre) Zone]. The Notice of Final Action was filed with the Las Vegas City Clerk on June 2, 2005. This approval is subject to:

1. Approval of applications for a Rezoning (ZON-6274) and a Site Development Plan Review (SDR-6275) by the City Council prior to issuance of any permits, any site grading, and all development activity on the site.
