Minutes:

MAYOR PRO TEM REESE declared the Public Hearing open.

LUCAS TUCKER, 300 South Fourth Street, appeared on behalf of the applicant. The Planning Commission approved the application subject to the applicant submitting an engineer's letter of approval stating the structure is sound. However, he did not have the letter, but he is diligently working on the letter and can provide it within 90 days.

COUNCILWOMAN TARKANIAN asked MARGO WHEELER, Director of Planning and Development Department, if it would cause any problems if this item is delayed so the applicant can obtain the letter. MS. WHEELER replied that if the condition is imposed, the applicant would be responsible to submit the letter in a time period established by the Council.

COUNCILMAN BROWN explained the purpose of the letter from a certified engineer is to ensure that billboards are structurally sound. He encouraged Mr. TUCKER to expedite the process.
