Minutes:

RASHAN JOSHUA COLLINS read from Nevada Revised Statutes. He claimed that he was injured during the Gay Pride Parade and is experiencing legal problems. He asked the Council to support him in fighting insurrection.

DANIEL PALMQUEST, Las Vegas resident, concurred with the previous speaker and also quoted from Nevada Revised Statutes. He suggested homosexual acts are illegal and should be stopped.

DOROTHY BARNES, Las Vegas resident, questioned MAYOR PRO TEM REESE if he was still granting special favors. She asked that people stop using her distress signal and remove her from their list.

A concerned citizen in wheelchair presented pictures showing lack of sidewalks at Walmart located on Charleston Boulevard and Paris Center, before Arville. He asked for some common courtesy. COUNCILWOMAN TARKANIAN requested a copy of the pictures. She acknowledged there have been sidewalk issues at this location.

JOE MAVIGLIA referred to Item 50 from the morning agenda. He gave a brief history of the bus system in Las Vegas and his efforts for better mass transit and expressed concern with the idea of moving the Downtown Transportation Center.

EVO GRECHOV, from Slovenia, Europe observed that no one is monitoring ADA compliance and suggested someone should instruct the construction industry.

ORLANDO DELGADO showed Council photographs of a building located at 713 East Sahara appearing to show a huge roach infestation. He placed calls with different jurisdictions and asked for someone to help MS. ANIFANT, who is 91 years old and is experiencing this issue. The agencies are failing the elderly people.
