PURPOSE/BACKGROUND:

On January 22, 2003 City Council approved the award of an Engineering Design Services Agreement for the Decatur Boulevard Rehabilitation - Sahara Avenue to Meadows Lane Project to Carter Burgess, Inc. and on February 17, 2005 City Council approved the First Amendment to include design of bus turnouts, bus turnout design phasing, additional aerial mapping, additional potholing and other related design services to the project. The Second Amendment represents design onsite improvements to parking, landscaping, commercial signage and for the relocation of storm drain drop inlets and fire hydrants; providing assistance in acquiring right-of-way and traffic signal easements and additional related design services to improve traffic flow not included in the original contract or previous amendment in the amount of \$522,610 which brings the total amount to \$1,336,103.
