PURPOSE/BACKGROUND:

The Workforce Investment Act of 1998 authorizes the expenditure of federal funds for workforce development services in locally determined workforce investment areas. The Chief Local Elected Officials (LEOs) Consortium was created and consists of elected officials of the Cities of Las Vegas, North Las Vegas, Henderson and Boulder City and the Counties of Clark, Lincoln, Nye and Esmeralda. Pursuant to the act, the LEOs have designated the Southern Nevada Workforce Investment Board (SNWIB) as the administrative entity and grant subrecipient to administer the WIA funds. This agreement describes the respective roles and responsibilities of the parties and defines the scope of their partnership. Key changes for the agreement include the Executive Director of the SNWIB reporting to the LEOs instead of the entire SNWIB Board and liability and repayment of funds shall be based on a per capita formula. The formula is for prospective liability and will be adjusted every two years, following a mandatory review by the LEOs .

RECOMMENDATION:

Staff recommends approval of the agreement between the LEOs and the SNWIB and authorization of the Mayor to execute any and all related agreements following approval as to form by the City Attorney.
