PURPOSE/BACKGROUND:

The Mayor and each member of City Council appoint one member to this board subject to ratification by the Council. The terms are concurrent with the term of the appointing City Council member. All members of this board must be City residents but are not required to reside in the specific Ward of the Councilmember making the appointment. There is no limit to the number of terms that may be served, and unexpired terms must be filled. Additionally, no less than one and no more than three members must be currently licensed owners or operators of a child care facility within the City. The other citizen members serve at large. Terry Clodt was appointed by Mayor Goodman; Julie Proud was appointed by the previous Councilmember for Ward 1; JoNell Thomas was appointed by Councilman Reese. These members serve at large and are eligible and wish to be reappointed. Lilliane Brumwell was appointed by the previous Councilmember for Ward 5 and serves as a Licensed Operator of a Child Care Facility representative. Ms. Brumwell has declined reappointment.

RECOMMENDATION:

Procedure for this Board is coterminous appointment by the appropriate member of Council. Options are:

Mayor Goodman to reappoint Terry D. Clodt OR appoint a new member
Councilwoman Tarkanian to reappoint Julie Proud OR appoint a new member
Councilman Reese to reappoint JoNell Thomas OR appoint a new member
Councilmember for Ward 5 to appoint a new member
