**PURPOSE/BACKGROUND:**

The Mayor and each member of City Council appoint one member to this committee subject to ratification by the Council. The terms are concurrent with the term of the appointing City Council member. All members of this board must be City residents but are not required to reside in the specific Ward of the Councilmember making the appointment. Terms are four years, and there is no limit to the number of terms that may be served. Mr. Greco was appointed by Mayor Goodman; Mr. Butters was appointed by the previous Councilmember for Ward 1; Mr. Judd was appointed by Councilman Reese; Mr. Sayles was appointed by the previous Councilmember for Ward 5. These members are eligible and wish to be reappointed.

**RECOMMENDATION:**

Procedure for this Board is coterminous appointment by the appropriate member of Council. Options are:

- Mayor Goodman to reappoint Mr. Greco or appoint a new member
- Councilwoman Tarkanian to reappoint Mr. Butters or appoint a new member
- Councilman Reese to reappoint Mr. Judd or appoint a new member
- Councilmember for Ward 5 to reappoint Mr. Sayles or appoint a new member
