AUTHORITY: Simple Council action on 11-20-91 and 12-4-91 to disband CPAC as it existed under Resolution dated 11-7-84, and restructure such that: committee consists of 5 members - 1 appointed by each Council member - with terms of the appointees running concurrent with the term of office of the elected official who made the appointment. **Amended by Council action 4-5-2000 to increase the membership to 7 members due to increase by two Councilpersons (Wards 5 and 6).**

TERM: Must run concurrent with term of elected official who made appointment. No limit to the number of terms.

NOTES: MUST BE CITY RESIDENT per Bill 90-51, Ordinance 3527.
Must be resident of City, but not necessarily the Ward of the appointing Council member.
No financial disclosure requirement.
