PURPOSE/BACKGROUND:

The Mayor and each member of City Council appoint one member to this committee subject to ratification by the Council. The terms are concurrent with the term of the appointing City Council member. All members of this board must be City residents but are not required to reside in the specific Ward of the Councilmember making the appointment. Terms are for four years with a limit of two full terms, and unexpired terms must be filled. Additionally, this is a compensatory board. Mr. Truesdell was appointed by Mayor Goodman; Mr. Davenport was appointed by the previous Councilmember for Ward 1; Mr. Evans was appointed by Councilman Reese; Mr. Goynes was appointed by the previous Councilmember for Ward 5. These members are eligible and wish to be reappointed.

RECOMMENDATION:

Procedure for this Board is a recommendation by the appropriate member of Council with the approval of Council. Options are:

- Mayor Goodman to reappoint Mr. Truesdell OR appoint a new member
- Councilwoman Tarkanian to reappoint Mr. Davenport OR appoint a new member
- Councilman Reese to reappoint Mr. Evans OR appoint a new member
- Councilmember for Ward 5 to reappoint Mr. Goynes OR appoint a new member
