To members of the City Council,

Attached you will find photos taken June 10th, 2007 at 8:00AM. They show construction material in the street in front of 9049 Waterfield Court. It is clearly marked Brown Casita. The lower right photo shows that at least some construction has begun as does to blue trash container residing in the front yard and shown on the left of the top photo.

Since no approval has been given how can they do that? The hearing for the public is scheduled *June 20, 2007 at 1:00PM* so approval has obviously not been given.

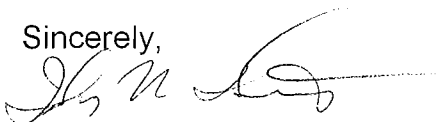
I do not object so much to the giant casita being built as long as it is in the back yard and does not change the street appearance of the existing home but I strongly object to the project having begun at least 11 days BEFORE the hearing.

I thought we all had to abide by the rules and needed to get approval before starting such a project. What if the neighbors go to the hearing and strongly object to such a change in the existing building code and the council, in its wisdom, refuses to grant approval? What then?

I feel the building inspector who probably has no awareness of the construction having begun should make them stop anything they are doing on this project until official approval by the City Council.
