Minutes:

MAYOR GOODMAN declared the Public Hearing open.

SCOTT McCAGE and SHEILA WAKELUM, Architects, Gensler of Nevada, Phoenix, AZ appeared on behalf of the applicant. MR. McCAGE stated they have been working with staff on the site design and architecture. They do not object to the conditions and desire to move forward with the project.

Because this project could be impacted with future road expansions, MAYOR GOODMAN questioned if Council should take this into consideration when voting. ASSISTANT CITY ATTORNEY BRYAN SCOTT added that the Council should take the project as it exists today and not take into consideration any improvement projects that may or may not happen in the future.

BART ANDERSON, Public Works, commented that the applicant has been working well with Public Works on the expansion of Martin Luther King Jr. Boulevard. The parcel has already dedicated the necessary right-of-ways. In addition, he read the amendment to Condition 12 which modifies the location of the proposed driveway. MR. McCAGE agreed with the amended condition.

TED RUSSELL, Las Vegas resident, stated Bank of America has a pilot program in Los Angeles, California where an illegal immigrant may apply and receive a Visa or a Visa loan without identification or social security number. He suggested if he made the same application, the results would be different. He opposed to any further Bank of American growth in the city of Las Vegas until their procedures are "Americanized" and rectified by eliminating such program.

COUNCILMAN BARLOW commended Bank of America for a job well done, specifically on working with staff regarding landscaping and egress/ingress. He appreciates their commitment to the community, as it is the beginning of something beautiful as Martin Luther King Jr. Boulevard widens and development progresses.

MAYOR GOODMAN declared the Public Hearing closed.
