We just learned about the session of the Planning Commission held last week that contained two agenda items that are of specific interest to us: Item 43 and 44.

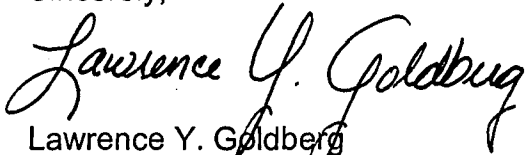
We have no record of receiving notice of these items from the Planning Commission even though we are on the adjoining property.

We surely object to both items and the approval that is being sought. We believe that the open storage of automobiles is unsightly and definitely deteriorates the adjoining retail uses. We have invested millions of dollars in our Center and believe that this is a use which is not compatible with our presentation or the adjoining properties.

As far as Item 44 is concerned, the condition was sought in order to prevent the impact that I have described above. This use is incompatible from a marketing and esthetic viewpoint with shopping center properties. Auto dealers ought to be in a specialized zone and many cities have provided for that. We believe that this is an encroachment on our use.

We would like to appear at the meeting if the items come up for further review - which I understand they will. Please note our objections and allow us to appear.
